POSITION SUMMARY

Delegates will represent the “voice of members” for Badgerland Council. Delegates will attend the Annual Meeting and will vote on various matters including elections of the Board of Directors, Officers, Members of the Leadership Development Committee, Council Delegates, and National Council Delegates. At the request of the Council Officers, Board of Directors, or Chief Executive Officer or designee, advise with respect to matters of importance regarding operations of the Council. These matters may include decisions about a wide range of items including: program options, product sales, retail options, adult development and relevant current issues important to girls and volunteers. There will be direct communication with the Badgerland Council Office of the CEO and key staff members. This position will also provide an opportunity for members to gain and enhance leadership skills through training and experience.

EXAMPLES OF DUTIES AND RESPONSIBILITIES

- Thoughtfully vote at the Annual Meeting on matters of importance to the membership including the election of the Board, Officers, LDC, and Delegates.
- Share opinions about, and influence council decisions, on topics including: program content and options, cookie program and fall fundraiser, shop merchandise, adult development and more.
- Serve as a representative of the volunteers and parents within the Badgerland Council.
- Serve as a brand ambassador of the Girl Scout movement and as a spokesperson and Girl Scout advocate to the local media, funders and at council events such as the Annual Meeting and Girl Scout Awards Ceremony.
- Attend and actively participate in Council Delegate meetings.

QUALIFICATIONS

Be a registered member of Girl Scouts of the USA, who lives the values of the Girl Scout Promise and Law including:

- **Girl Focus:** Understand the issues facing girls locally and on a broader scope and be willing to speak up about how we can best address those issues through Girl Scouting
- **Personal Integrity:**
 - Dependability, honesty and credibility
 - Ability to work collaboratively in a team and support group decisions even if they differ from your own
- **Foster Diversity:** Understand, respect and embrace differences
- **Adaptability:** Flexibility, creativity, patience, understanding and ability to work effectively with others
- **Computer skills:** Basic technology skills including regular access to an active email account, an understanding of social media and a commitment to using internet meeting technology
- **Communication skills:** Good written and verbal communication skills
- **Dependability:** Delegates who are absent from any two consecutive meetings in their entirety without good cause acceptable to the Chair, may be removed as a Delegate by a majority vote of the Delegates present.
